IMPORTANT: CHINA VISA APPLICATION FORM CHECKLIST

- Application form must be completed in *Capital Letters*.
- This form must be completed on computer. If you need any special assistant, you can fill in the form by handwriting and then we can help you to type it on the computer.
**Must print the form on one side only. Please do not print it in double sides.*
- If some of the items do not apply, please type **N/A or None**.
- Section 1.9 Local ID/Citizenship Number:** Please put Driver License Number or Birth Certificate Number in this section.
- Section 1.15 Current Occupation(s):** If you check the box of “Company employee”, please write your position name next to that row by handwriting.
- Section 1.17 Employer/School:** If you are retired, please put “RETIRED” under the Name, put “N/A” under Phone Number, Address, & Zip Code.
- Section 1.23 Major family members:** If you are married, you must put your spouse information in this section. If you have children, please also put your children’s information under this section.
- Section 2.2 Intended number of entries:**
For Canadian Passport Holder: Please leave it blank. Note that the intended number of entries depend on the Passport Expiry date. Same price for multiple entries and single entries. If you prefer to have more entries to China, please renew your passport and then apply for China Visa.
For Non-Canadian Passport Holder: Price and the policy for the intended number of entries vary. Please contact us for details.
- Section 2.9 Have you ever been granted a Chinese visa? If applicable, please specify the date and place of the last time you were granted the visa:** If the answer is YES, please specify the date and place of the last time you were granted the visa.
- Section 2.10 Other countries or territories you visited since 2015:** Please put the countries that you **visited since 2015** according to your passport stamps. This is new requirement from China Embassy for visa application.
- Please sign on Part 4: Declaration & Signature:** Signature must be the same as your passport’s signature. Please use black or blue pen to sign your signature.
- Please make sure your Passport is signed.
- One China Visa size colour photo against a light background (size: 48mm x 33mm).
 - **NOTE: Bare head, no jewelry, no necklace, no earring and ears showing (not covered by hair).**
- Old passport are required if current passport issued after Jan 1, 2015.** If old passport not available, please sign the *Old Passport Not Available Letter* and include with application.
- Please mail original passport (and old passport if required), 1x China visa size colour photo, and signed China Visa Application Form to our office 45 days before departure date.
